Mr. Mertz called the public meeting to order at 6:00 p.m. Mr. Mertz and Mr. Seamus Boyce, legal counsel, explained that opportunity for objections and support for the terms of the proposed contract would be given at both 6:00 and 6:30 p.m. There was no one present who expressed interest in commenting on the terms of the proposed contract between 6:00 and 6:30 p.m.

Mr. Mertz stated we have been very fortunate in Perry Township that Mr. Mapes stepped in to lead the district. I have had the opportunity to work with Mr. Mapes for the past six months and have been very, very pleased. He is the first to sav he did not do it on his own and had a lot of help.

Mr. Seamus Boyce stated Indiana code requires a school board to hold a public meeting to consider a proposed superintendent contract. Written notice has been provided in typical ways you advertise your board meeting and in addition it was advertised in the <u>Court & Commercial Record</u> and <u>The Indy Star</u> ten days prior to this meeting. There is an opportunity for both objections and support of the terms of the contract. Wait at least 7 days before you can take final action on the contract.

Mr. Boyce reviewed the terms of the proposed contract. Mr. Boyce asked if there is any person present that objects to the terms of the proposed contract. There were none.

Mr. Boyce asked if anyone wishes to offer support of the proposed contract. Mr. Denning echoed Mr. Mertz' sentiments. It was a unique opportunity that afforded us an extended trial run with Mr. Mapes leading our school corporation and we would be very fortunate to have him in the future. Mr. Morris stated we have had the opportunity to experience how Mr. Mapes deliberates before making a decision and it is very complimentary to him. Mr. Mercer stated he worked with Mr. Mapes for approximately six months and it was very refreshing from what we have been used to. Mr. Mercer said he is very pleased that Mr. Mapes has consented to stay here to lead Perry Township

Schools.	He said Mr. Mapes has done a good job and will continue to do a good job. Mr. Johnson stated	d he	
concurs.	He has worked with Mr. Mapes since January and feels he has done a great job for the district.	Mr.	
Johnson personally thanked him for stepping in and doing a great job.
