Perry Township Schools 2020-21 Classroom Reopening Plan

FIRST STUDENT DAY: WEDNESDAY, AUGUST 5

In-person classes will begin on Wednesday, August 5, and will continue Monday - Friday at their regularly scheduled times. Remote learning courses are available to students in high-risk health categories who are unable to return to school at the beginning of the year. The option is also available to parents who are not comfortable sending their student(s) back to school at this time.

(Note: The E-Learning curriculum will be limited and may not mirror the full curriculum/experience of in-person instruction.)

ENHANCED CLEANING

- Normal cleaning routines will be enhanced by disinfecting frequently touched surfaces (drinking fountains, sink handles, door handles, etc.)
- Sharing equipment will be limited when possible and cleaned between uses when used by more than one person or group.

COVID-19 POSITIVE PROTOCOL

 Staff or students who have had a positive exposure, symptoms, or diagnosis of COVID-19 may return to school 14 days after symptoms first appeared and have been fever free for 24 hours or with a doctor's release to return to school.

HEALTH & SAFETY PROTOCOL



FACE COVERINGS

All employees and students in Pre-K - 12 will be required to bring a face covering and wear it in designated areas and in certain circumstances when social distancing may not be possible (e.g. hallways, bus, cafeteria serving lines). Masks will be provided to any student or staff member who needs one.



TRANSPORTATION

Buses will be cleaned and disinfected daily, using EPA-approved products. Seating charts will be assigned on all bus routes, and siblings will be seated together or near each other.



BUILDINGS

All buildings will be cleaned and disinfected throughout the day. Frequently-touched surfaces, like sink handles and doors, will be cleaned multiple times per day, using EPA-approved products.



HAND-WASHING

Regular hand-washing will be encouraged for students and staff. Hand sanitizer will be available in classrooms and common areas when hand-washing isn't an option.



SOCIAL DISTANCING

Social distancing will be practiced as much as possible.



TRAINING

Professional development on symptoms and screening measures will be provided to all staff at the start of the school year.



NURSE'S CLINIC LOCATIONS

There will be a designated area for students displaying symptoms and waiting to be picked up. A separate area will be designated for medication distribution.



WATER BOTTLES

Students are encouraged to carry water bottles with them at school.



SYMPTOM SCREENING

Families are expected to screen their children and keep them home if ill. Students and staff should stay at home if they have a fever of 100.4° F, or exhibit symptoms of COVID-19.

COVID POSITIVE SYMPTOMATIC

- Students will stay home and will access assignments on Canvas through their classroom teacher.
- Parents will contact child's school to report absence.
- Return to school if at least 24 hours have passed since recovery (defined as resolution of fever without the use of medications and improvement in symptoms) AND 10 days have passed since symptoms first appeared.

Ask these three questions

(If all 3 answers are yes, you may contact your child's school about returning.)

- 1. Has it been at least 10 days since the individual first had symptoms?
 - 2. Has it been at least three days since the individual had a fever?
 - 3. Has is been at least three days since the individual's symptoms have improved, including cough and shortness of breath?

COVID POSITIVE ASYMPTOMATIC

- Students will stay home and will access assignments on Canvas through their classroom teacher.
- Parents will contact child's school to report absence.
- Return to school 10 days from the positive test assuming no symptoms have developed.

NO COVID TEST SYMPTOMATIC

- Students will stay home and will access assignments on Canvas through their classroom teacher.
- Parents will contact child's school to report absence.
- Return to school if at least 24 hours have passed since recovery (defined as resolution of fever without the use of medications and improvement in symptoms) AND 10 days have passed since symptoms first appeared.

Ask these three questions:

(If all 3 answers are yes, you may contact your child's school about returning.)

- 1. Has it been at least 10 days since the individual first had symptoms?
 - 2. Has it been at least three days since the individual had a fever?
 - 3. Has is been at least three days since the individual's symptoms have improved, including cough and shortness of breath?

CHANGES TO THE CLASSROOM & SCHOOL ENVIRONMENT

-BACK-TO-SCHOOL EVENTS-

- Family events will be primarily virtual or sent out electronically.
- Face coverings and social distance are highly encouraged for all student events held in-person.

-EXTRACURRICULARS ACTIVITIES

 Students enrolled in remote learning will be permitted to participate in extracurricular activities.

-CAFETERIA ADJUSTMENTS-

- No visitors for lunch.
- Serving lines will be cleaned frequently.
- Cafeteria seating will be socially distanced, and alternative areas will be utilized.

-PHYSICAL EDUCATION

 To begin the 2020-21 school year, students will not be required to dress for P.E. to minimize locker room interactions.

-RECESS-

Playground usage will be staggered to reduce the mixing of groups.

-SCHEDULES-

Each school will communicate more information regarding individual building plans.

OTHER PREVENTION ITEMS

- No external field trips or convocations until further notice.
- Visitors and guests who must enter the school (ex. to pick up a student) will be limited to the main office and are required to wear a face mask.
- Perry Township Schools is eliminating perfect attendance incentives for the 2020-21 school year.

Full-time, In-person Learning

Only students in grades K-5 may receive in-person instruction Monday through Friday. Full-time learning is not available for students in 6-12.

Hybrid Option (In-person learning + remote learning)

through Friday.

Only students in grades 6-12 may select the hybrid model. Students will receive two days of in-person instruction and three days of remote learning to ensure 50 percent capacity in school buildings. The schedule is determined by the first letter of the student's last name.
