Each of the fringe benefits described in the Administrator Handbook shall be provided to the Executive Leadership Team Member (ELTM) upon the same terms and conditions as described in the Employment Agreement and Administrator Handbook, except for the following modifications:

1. Insurance and Other Benefits:

- A. **Life Insurance:** The district shall pay for a group term life insurance policy with a face value of \$300,000, provided the team member is actively employed.
- The policy value remains at \$300,000 when an ELTM retires from the district, provided premiums are paid to the district during the retirement period.
 - If the employee has retired, on the member's 65th birthday, the policy will decrease to \$150,000 and remain at this level until the member's 70th birthday.
 - At age 70, the member may convert the policy to an individual policy, and the member will no longer be on the district's term life insurance plan.
- B. **Retirement Plan:** The district shall contribute \$12,000 annually (\$461.54 x 26 pay periods) to a 403(b) or 457(b) retirement plan. Contributions shall be 100% vested and recorded as income for the member and must be used as a retirement plan contribution.
- C. **Cell Phone Allowance:** The district shall contribute \$1,200 annually (\$46.15 x 26 pay periods) for a cell phone stipend.
- D. **Membership:** The district shall annually pay for two (2) professional membership fees on behalf of the member
- E. **Professional Travel:** With the approval of the Superintendent and Board approval, the member may attend a national conference for professional development in their assigned area of school administration.

2. All benefit payments and contributions from the district cease upon the member's separation from active employment.

Each of the fringe benefits described in the Administrator Handbook shall be provided to the Executive Leadership Team Member (ELTM) upon the same terms and conditions as described in the Master Contract and Administrator Handbook, except for the following modifications:


1. Insurance and Other Benefits:

- A. **Life Insurance:** The district shall pay for a group term life insurance policy with a face value of \$300,000, provided the team member is actively employed.
 - The policy value remains at \$300,000 when an ELTM retires from the district, provided premiums are paid to the district during the retirement period.
 - If the employee has retired, on the member's 65th birthday, the policy will decrease to \$150,000 and remain at this level until the member's 70th birthday.
 - At age 70, the member may convert the policy to an individual policy, and the member will no longer be on the district's term life insurance plan.
- B. **Retirement Plan:** The district shall contribute \$12,000 annually (\$461.54 x 26 pay periods) to a 403(b) or 457(b) retirement plan. Contributions shall be 100% vested and recorded as income for the member and must be used as a retirement plan contribution.
- C. **Vehicle Allowance:** The district shall contribute \$3,600 annually (\$138.46 x 26 pay periods) in lieu of mileage reimbursement.
- D. **Cell Phone Allowance:** The district shall contribute \$1,200 annually (\$46.15 x 26 pay periods) for cell phone reimbursement.
- E. **Membership:** The district shall annually pay for two (2) professional membership fees on behalf of the member
- F. **Professional Travel:** With the approval of the Superintendent and Board approval, the member may attend a national conference for professional development in their assigned area of school administration.

2. All benefit payments and contributions from the district cease upon the member's separation from active employment.

Notwithstanding any of the above language, the School Corporation, by official action of the Board, may suspend the School Corporation's employer contribution, in whole or in part, to any or all of the listed benefits for a period of time.

Each of the fringe benefits described in the Administrator Handbook shall be provided to the Executive Leadership Team Member (ELTM) upon the same terms and conditions as described in the Master Contract and Administrator Handbook, except for the following modifications:


1. Insurance and Other Benefits:

- A. **Life Insurance:** The district shall pay for a group term life insurance policy with a face value of \$300,000, provided the team member is actively employed.
 - The policy value remains at \$300,000 when an ELTM retires from the district, provided premiums are paid to the district during the retirement period.
 - If the employee has retired, on the member's 65th birthday, the policy will decrease to \$150,000 and remain at this level until the member's 70th birthday.
 - At age 70, the member may convert the policy to an individual policy, and the member will no longer be on the district's term life insurance plan.
- B. **Retirement Plan:** The district shall contribute \$12,000 annually (\$461.54 x 26 pay periods) to a 403(b) or 457(b) retirement plan. Contributions shall be 100% vested and recorded as income for the member and must be used as a retirement plan contribution.
- C. **Vehicle Allowance:** The district shall contribute \$3,600 annually (\$138.46 x 26 pay periods) in lieu of mileage reimbursement.
- D. **Cell Phone Allowance:** The district shall contribute \$1,200 annually (\$46.15 x 26 pay periods) for cell phone reimbursement.
- E. **Membership:** The district shall annually pay for two (2) professional membership fees on behalf of the member
- F. **Professional Travel:** With the approval of the Superintendent and Board approval, the member may attend a national conference for professional development in their assigned area of school administration.

2. All benefit payments and contributions from the district cease upon the member's separation from active employment.

Notwithstanding any of the above language, the School Corporation, by official action of the Board, may suspend the School Corporation's employer contribution, in whole or in part, to any or all of the listed benefits for a period of time.

Each of the fringe benefits described in the Administrator Handbook shall be provided to the Executive Leadership Team Member (ELTM) upon the same terms and conditions as described in the Master Contract and Administrator Handbook, except for the following modifications:


1. Insurance and Other Benefits:
 - A. **Life Insurance:** The district shall pay for a group term life insurance policy with a face value of \$300,000, provided the team member is actively employed.
 - The policy value remains at \$300,000 when an ELTM retires from the district, provided premiums are paid to the district during the retirement period.
 - If the employee has retired, on the member's 65th birthday, the policy will decrease to \$150,000 and remain at this level until the member's 70th birthday.
 - At age 70, the member may convert the policy to an individual policy, and the member will no longer be on the district's term life insurance plan.
 - B. **Retirement Plan:** The district shall contribute \$12,000 annually (\$461.54 x 26 pay periods) to a 403(b) or 457(b) retirement plan. Contributions shall be 100% vested and recorded as income for the member and must be used as a retirement plan contribution.
 - C. **Vehicle Allowance:** The district shall contribute \$3,600 annually (\$138.46 x 26 pay periods) in lieu of mileage reimbursement.
 - D. **Cell Phone Allowance:** The district shall contribute \$1,200 annually (\$46.15 x 26 pay periods) for cell phone reimbursement.
 - E. **Membership:** The district shall annually pay for two (2) professional membership fees on behalf of the member
 - F. **Professional Travel:** With the approval of the Superintendent and Board approval, the member may attend a national conference for professional development in their assigned area of school administration.
2. All benefit payments and contributions from the district cease upon the member's separation from active employment.

Notwithstanding any of the above language, the School Corporation, by official action of the Board, may suspend the School Corporation's employer contribution, in whole or in part, to any or all of the listed benefits for a period of time.
