PERRY TOWNSHIP SCHOOLS PLAN TO REOPEN ON TIME AND IN PERSON WITH A REMOTE LEARNING OPTION ON JULY 29, 2020.



ENHANCED CLEANING PROTOCOLS

Normal cleaning routines will be enhanced by disinfecting frequently touched surfaces (drinking fountains, sink handles, door handles, etc.) Sharing equipment will be limited when possible and cleaned in between uses when used by more than one person or group.

COVID-19 POSITIVE PROTOCOL

Staff or students who have had a positive family exposure, symptoms, or diagnosis of COVID-19 may return to school 10 days after symptoms first appeared and have been fever free for 72 hours or with a doctor's release.

HEALTH AND SAFETY PROTOCOLS

FACE COVERINGS



The Marion County Health Department requires face masks to be worn by all staff and students when unable to social distance.

SYMPTOM SCREENING



Families are expected to screen their children and keep them home if ill. Students and staff should stay home if they have a fever of 100 degrees or higher.

COHORTING



Students will remain with the same group of students throughout the day. Related services and other small groups will be scheduled by class to keep cohorts together.

SEATING AND SOCIAL DISTANCING



Staff will be required to assign seats on buses. Students will have assigned areas and/or seats in the classroom and follow travel patterns throughout the school day.

SEPARATE CLINIC LOCATIONS



Designated clinic locations will be created for students displaying symptoms and waiting to be picked up by a parent or guardian.

CAFETERIA



A limited number of students will be allowed in the cafeteria to allow appropriate social distancing.

HAND WASHING



Staff and students must practice good hand washing practices throughout the day. Hand sanitizer will be available for when hand washing isn't an option.

TRAINING



Professional development will be provided to all staff at the start of the school year on symptoms and screening measures.

WATER BOTTLES



Students will be allowed to carry water bottles. All water fountains will only be used for the purpose of filling water bottles.

JWR - Building Operation Plan

Due to the nature and structure of the SOAR, MAP and CIOP programs here at the JWR building, we are able to maintain social distancing and limit the interaction among students involved in our separate programs. Only slight changes are necessary to follow most CDC guidelines for schools.

Morning Arrival

Our normal arrival procedures will remain in place. Arrival times of students is already staggered – therefore – no changes are necessary.

Movement within the building

Students will report directly to their assigned classroom in the morning. All movement throughout the day will be directed by the classroom teachers. With only three classrooms, there are no passing periods or times when the three classes would come in contact with one another. All restroom and cafeteria trips will be coordinated as well to limit contact with the other classes.

Lunch

Lunch periods are staggered giving each classroom enough space to practice social distancing. Seating charts will also be developed to ensure students remain distant.

Dismissal

Dismissal is already staggered. There are no changes planned.

Visitors

All visitors will be asked to wear a mask upon entering building. Visitors will report to the main office. Visitors will not be allowed to enter classrooms.

Sick Employees/Students

Students that become sick at school will be held in a designated waiting area where they can wait until picked up by a guardian.

What happens when you are sick?

COVID Positive Symptomatic:

- Student or staff member will be excluded from school
- Student can return when “yes” can be answered for the following questions
 - Has it been at least 10 days since the individual first had symptoms?
 - Has it been at least 3 days since the individual had a fever without the use of medication?
 - Has it been at least 3 days since the individual’s symptoms have improved, including cough and shortness of breath?

COVID Positive Asymptomatic:

- Student or staff member will be excluded from school
- Student or staff member can return to school 10 days from positive test granted no symptoms developed.

No COVID Test Symptomatic:

- Student or staff member will be excluded from school
- Student can return when “yes” can be answered for the following questions
 - Has it been at least 10 days since the individual first had symptoms?
 - Has it been at least 3 days since the individual had a fever without the use of medication?
 - Has it been at least 3 days since the individual’s symptoms have improved, including cough and shortness of breath?
