Mr. Sampson recommended approval of an agreement with Sinclair Recreation for playground renovations at Douglas MacArthur and Homecroft Elementary Schools. The playground project will consist of new playground equipment at both Douglas MacArthur and Homecroft Elementary Schools.

All renovated playgrounds will receive "pour-in-place" rubber ground surfacing. The project cost for Douglas MacArthur is \$470,345 and \$447,303 for Homecroft with a combined total of \$917,648. Sinclair Recreation will remove the old equipment and install the new Game Time playground equipment and oversee the installation of the ground surface. The purchase was made through Omnia Partners, an approved cooperative purchasing group that satisfies all legal requirements of the bid process.
